For what purpose and on what basis we process personal data

How long we store personal data

Sharing personal data with third parties

Securro B.V. provides only to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, that we use

Securro B.V. does not use cookies or similar techniques.

View, modify or delete data

You have the right to view, correct or delete your personal data.

You also have the right to withdraw your consent to data processing or to object to the processing of your personal data by Securro B.V. and you have the right to data portability. This means that you can submit a request to us to send the personal data we have to you in a computer file to you or another organisation mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to hvanoosterhout@securro.com.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request.
